**NOTICE REGARDING FINAL ACCOUNTING AND FINAL DISTRIBUTION
FOR RELIANCE INSURANCE COMPANY, IN LIQUIDATION**

PLEASE TAKE NOTICE that Jessica K. Altman, in her official capacity as Insurance Commissioner of the Commonwealth of Pennsylvania, and as such, Statutory Liquidator of Reliance Insurance Company, is providing this Notice that she has filed her Application for Approval of Notice of Final Accounting and Plan for Final Distribution (Application) which sets forth the steps taken during the liquidation of Reliance Insurance Company and the proposal for a final distribution of assets.

The Application states that, with the exception of certain federal claims, a 100% distribution has been or will be paid on all priority class (a), (b) and (c) Notices of Determination (NODs). There were no priority class (d) NODs. The total class (e) NODs approved by the Court total \$630,138,012 and all remaining assets available for distribution total \$30,254,480, after a reserve for the payment of federal claims totaling \$16,473,924 and the Liquidator's administrative expenses totaling \$17,773,571. The Liquidator is therefore recommending a final distribution of approximately 4.8% on all class (e) NODs with allowed amounts approved by the Court. There will be no assets available for NODs in priority classes below (e).

Any responses to the Application must be filed in writing with the Commonwealth Court of Pennsylvania, Office of the Prothonotary, 601 Commonwealth Avenue, Suite 2100, Harrisburg, PA 17106-9185 **NO LATER THAN May 10, 2021** and must reference Docket No. 1 REL 2001. Responses not received by that date will be forever barred. All responses must be clearly and concisely written and state the basis for the objection. A copy of the filed response must be provided to the Liquidator at the address noted below.
