


I, Louis J. Schwartzberg, Esquire, being duly sworn, depose and state as follows:

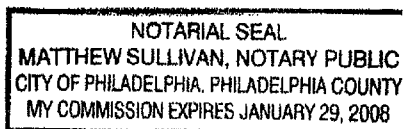
