I, Kassem L. Lucas, Esquire, being duly sworn, depose and state as follows:



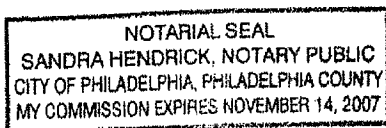
Petition to Approve Settlement between Reliance Insurance Company (In Liquidation) and the PRS Entities. (Attached).


