**NOTICE OF INTENT TO SUBMIT PROPOSAL TO
DISTRIBUTE ASSETS UNDER 40 P.S. §221.36**

On October 12, 2006, M. Diane Koken, Insurance Commissioner of the Commonwealth of Pennsylvania (“Commissioner” or “Liquidator”), in her official capacity as Liquidator of Reliance Insurance Company (“Reliance” or “Company”), and pursuant to her authority under Article V of the Pennsylvania Insurance Department Act of 1921, 40 P.S. §§ 221.1 – 221.63, (the “Act”) transmitted notice as required under 40 P.S. § 221.36(d) to (1) the Commissioners of Insurance of each of the states in which Reliance was licensed to do business; and (2) each guaranty association in each state in which Reliance was licensed to do business, of the intent to submit a proposal to distribute assets under 40 P.S. § 221.36.

As provided by 40 P.S. § 221.36(d), the Petition to Approve Liquidator's Fourth Proposal to Distribute Assets to State Guaranty Associations shall be filed on or about thirty days from October 12, 2006.
