**PRAECIPE TO WITHDRAW THE DECEMBER 20, 2007  
PETITION TO APPROVE A SETTLEMENT AGREEMENT  
BETWEEN RELIANCE AND CONSOLIDATED FREIGHTWAYS**

To the Prothonotary:

On December 20, 2007, Reliance Insurance Company (in Liquidation) ("Reliance") filed a petition to approve a settlement agreement between itself and Consolidated Freightways Corporation ("Consolidated Freightways"), with a proposed form of order. On January 2, 2008, Reliance filed a praecipe to substitute a new proposed form of order for the form of order originally attached to the petition.

Reliance hereby withdraws the above described petition and substituted form of order, with the knowledge, consent and approval of Consolidated Freightways. After further discussions concerning the adjustment and payment of "uncovered" AL/GL claims going forward, Reliance and the Consolidated Freightways have agreed that these claims will be adjusted and paid in accordance with the Court's existing Collateral Allocation Order of October

4, 2006. Reliance will continue to report to the Court pursuant to the reporting procedures established in the Collateral Allocation Order.


