Reliance Insurance Company (In Liquidation) ("Reliance") hereby files the Order of Judge Anita B. Brody of the United States District Court for the Eastern District of Pennsylvania, dated February 16, 2009 ("Order"), under 269 M.D. 2001 and 553 M.D. 2008. This Praecipe is being filed under both docket numbers because the original Notice of Removal referred to docket No. 269 M.D. 2001, instead of docket No. 553 M.D. 2008. This Order clarifies that the Notice of Removal of Defendants Underwriting Members of Syndicates 33, 506 and 205 removed only the Complaint docketed by the Commonwealth Court of Pennsylvania at

553 M.D. 2008 “and did not remove the Reliance Liquidation Proceeding from the Commonwealth Court of Pennsylvania docketed at 269 M.D. 2001,” and remands this matter to the Commonwealth Court of Pennsylvania at docket No. 553 M.D. 2008.



AND NOW, on this 16th day of February, 2009, it is hereby ORDERED that, pursuant to the Stipulation executed by counsel for Plaintiff Joel S. Ario, Insurance Commissioner of the Commonwealth of Pennsylvania, in his official capacity as Statutory Liquidator of Reliance Insurance Company (In Liquidation), and Defendants Underwriting Members of Syndicates 33 and 205 ("Defendants"): (1) Defendants' Notice of Removal removed only the Complaint filed against Underwriting Members of Syndicates 33, 205 and 506 docketed by the Commonwealth Court of Pennsylvania at 553 M.D. 2008 and did not remove the Reliance Liquidation Proceeding from the Commonwealth Court of Pennsylvania docketed at 269 M.D. 2001; (2) this matter is to be remanded to the Commonwealth Court of Pennsylvania

at docket No. 553 M.D. 2008; (3) each party shall bear its own costs and attorney's fees incurred in connection with all proceedings in this Court including, but not limited to, Defendants' Notice of Removal and Plaintiff's Motion for Remand; and (4) nothing herein affects any of the claims and defenses available to the parties in connection with the underlying action, all of which claims and defenses are preserved, and the Court makes no rulings on the merits of any of the issues raised on the motion for remand.


