ORDER

AND NOW this _____ day of _____, 2001, upon consideration of petitioner's Emergency Petition to Modify and Clarify the Court's August 2, 2001 Order to Extend the 60-Day Stay As to Additional Related Cases, it is hereby ORDERED that the petition is GRANTED. This Court's August 2, 2001 order is hereby amended to include the following cases:

1. Allison Desmond, et al. v. BankAmerica Corp., et al., Superior Court of the State of California (San Francisco County), Case No. 998629;
2. In re Xerox Securities Litigation, United States District Court of Connecticut, 3:99 CV 2374;
3. Butler v. Marine Military Academy, Judicial District Court, Cameron County, Texas, Cause No. 99-11-4891-E;
4. Bart A. Brown, Jr., et al. v. Anderson Consulting, et al., District Court of Harris County, Texas, Cause No. 98-30416.

an additional stay of 180 days in order to permit her to properly and carefully analyze the status of each case, its posture and merits, settlement value and potential for settlement, as well as defense strategy.

2. On August 2, 2001, the Court entered an order granting the Rehabilitator's petition and extending the stay of the major cases for an additional 180 days. See Tab 1.

3. The Rehabilitator has recently learned that the following cases, which are substantially related to the major cases identified in Exhibit "A" to the Petition, had been inadvertently omitted from the Petition:

1. Allison Desmond, et al. v. BankAmerica Corp., et al., Superior Court of the State of California (San Francisco County), Case No. 998629;
2. In re Xerox Securities Litigation, United States District Court of Connecticut, 3:99 CV 2374;
3. Butler v. Marine Military Academy, Judicial District Court, Cameron County, Texas, Cause No. 99-11-4891-E;
4. Bart A. Brown, Jr., Chapter 7 Trustee for FoxMeyer Corporation v. Anderson Consulting, et al., District Court of Harris County, Texas, Cause No. 98-30416.

The claims and issues in these four cases mirror or substantially overlap with the cases identified in Exhibit A of the Court's August 2 order.

4. Allison Desmond v. BankAmerica Corp. is a securities litigation in California state court that asserts claims parallel to those in the federal securities litigation In re BankAmerica Corp. Secur. Litig., Case No. 2 on Exhibit A to the August 2 Order. The California state court action arises from the same events and transactions that gave rise to the federal court action, In re BankAmerica Corp. Secur. Litig.

5. In re Xerox Securities Litigation asserts claims that parallel the two Xerox securities litigation, Case No. 6 on Exhibit A, and arises out of the same events and transactions.

6. Butler v. Marine Military Academy is one of five cases against the Marine Military Academy, each of which arises out of alleged hazing and assault on students at the Academy, Case No. 3 on Exhibit A.

7. Bart A. Brown, Chapter 7 Trustee for FoxMeyer is an action brought by the Chapter 7 Trustee for FoxMeyer Company against Arthur Andersen & Co. and Andersen Consulting ("Andersen") for fraud, negligence and breach of contract in the installation and implementation of its computer information systems. In Bart A. Brown, the Trustee alleges that Andersen's actions substantially contributed to Foxmeyer's insolvency. The claims in this case are related to those in Zuckerman v. FoxMeyer, Case No. 9 on Exhibit A, in which plaintiffs are claiming that Foxmeyer's officers and directors mismanaged the company causing the company to become insolvent. In Zuckerman, the defendant officers and directors contend that it was Andersen's wrongful actions in installing and implementing the computer systems that caused Foxmeyer's insolvency. Accordingly, there is a substantial overlap in the claims and issues in the two cases.

8. There would be no prejudice to the parties to these cases. Any prejudice that may result from a stay would be substantially outweighed by the critical necessity of the stay.


WHEREFORE, the Rehabilitator requests that the Court modify and clarify its August 2, 2001 order to extend the stay for 180 days as to the following four cases:

1. Allison Desmond, et al. v. BankAmerica Corp., et al., Superior Court of the State of California (San Francisco County), Case No. 998629;

2. In re Xerox Securities Litigation, United States District Court of Connecticut, 3:99 CV 2374;
3. Butler v. Marine Military Academy, Judicial District Court, Cameron County, Texas, Cause No. 99-11-4891-E;
4. Bart A. Brown, Jr., Chapter 7 Trustee for FoxMeyer Corporation v. Anderson Consulting, et al., District Court of Harris County, Texas, Cause No. 98-30416.



AND NOW this 2nd day of August, 2001, upon consideration of petitioner's Emergency Petition to Extend the 60-Day Stay Pursuant to Paragraph 22 of the Commonwealth Court's May 29, 2001 Order, it is hereby ORDERED that the petition is GRANTED insofar as this Court specifically finds that it is in the best interests of the estate of Reliance Insurance Company, as well as the policyholders as a whole, the creditors and other interested parties, that proceedings and actions, including but not limited to discovery, in each of the cases identified in Exhibit "A" hereto should be stayed for a period of 180 days, such period to commence on the date of this order. With respect to suits and other proceedings outside the Commonwealth of Pennsylvania and in the federal courts of the United States, this Order constitutes the request of this Court for comity in the extension of the stay by such courts or tribunals, and that those courts afford this order deference by reason of this Court's responsibility for and supervisory authority over the rehabilitation of


