**STIPULATED ORDER REGARDING SCHEDULING**

IT IS HEREBY STIPULATED AND AGREED this 15<sup>th</sup> day of June, 2004, by and between Petitioner M. Diane Koken, Insurance Commissioner of the Commonwealth of Pennsylvania, in her official capacity as Liquidator of Reliance Insurance Company, and the Respondent Guaranty Associations, through their respective counsel, that the Case Management Order pertaining to the above-captioned matter, entered by the Court on December 17, 2003, and modified by Stipulated Order on May 7, 2004, shall be further modified as follows:

- a) Discovery shall be complete by August 31, 2004.
- b) The parties shall file all pre-trial motions no later than September 17, 2004.
- c) The Liquidator shall disclose all expert witnesses and reports no later than September 30, 2004.
- d) The Guaranty Associations shall disclose all expert witnesses and reports no later than October 22, 2004.
- e) The parties shall file a pre-trial statement no later than November 15, 2004.
- f) The Court shall hold a pre-trial conference on or after December 1, 2004.
- g) The Court shall hold a hearing on or after December 8, 2004.


Further, the briefing schedule for the Liquidator's Motion for Partial Summary Judgment is as follows:
